- Applications must be made at least 2 week prior to the proposed commencement date of the bus service. You will be informed whether your application has been accepted or rejected.
- Goh Transport reserves the right to reject applications without giving any reason whatsoever. Approvals for application are granted at the sole discretion of Goh Transport. Some of the actions that will be taken into consideration include the availability of seats or the relevant bus route and whether the application is for two-way bus services.
- The annual bus fares will be collected over 9 months in January, February, March, April, May, July, August, September and October. There will be no collections for the months of June, November and December.
- Payment of the bus services charges must be made by way of cheque in favor of "Goh Transport Service Co. Pte Ltd." Payment is due once you received the bus fare payment record card.
- The collection for the bus fare is **on the first week of each month.**
- **Payment for school bus fee must be made within ONE weeks. Failure to make payment within the stipulated time may result in suspension of services.**
- One month notice is required for termination of our bus service, and it applies throughout the year except for the first month of service.
- We reserve the right to stop any students from taking our bus service if the child is deemed to pose a danger to other students or continuously create problems in the bus.
- All students are expected to be seated throughout the entire bus journey.
- Student who residences located within the Electronic Road Pricing (ERP) scheme, Goh Transport is allowed to incorporate a surcharge to cover the prevailing ERP rates.
